2	Tax Returns	Filed annually with refunds of tax deducted at source received yearly . TDS was on fixed deposits of SERWA.	It were filed earlier as block of three years . Therefore some of tax returns in between was not filed as time barred . Due to this tax refund of the said year stands lost / not recoverable.
3	Tds on Transactions of RWA	Now serwa has taken TDS number , which was never taken by earlier SERWA . therefore TDS compliance was never done in earlier regime . Now we withhold taxes and do needful as needed.	It was never done in the past , hence it remained not complied.
4	Minimum Wage to Security Guards	Minimum wage was enforced as accepted by Society also who pays 50% of their wage.	Guards were paid lower salary and continued as standard practice.
